

## EVALUATION LICENSE AGREEMENT

**IMPORTANT: PLEASE READ THIS EVALUATION LICENSE AGREEMENT CAREFULLY. DOWNLOADING, INSTALLING, OR USING CISCO OR CISCO-SUPPLIED SOFTWARE CONSTITUTES ACCEPTANCE OF THIS EVALUATION LICENSE AGREEMENT.**

CISCO SYSTEMS, INC. ("CISCO") OR ITS SUBSIDIARY LICENSING THE SOFTWARE INSTEAD OF CISCO IS WILLING TO LICENSE THIS SOFTWARE TO YOU ONLY UPON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS CONTAINED IN THIS EVALUATION LICENSE AGREEMENT PLUS ANY ADDITIONAL LIMITATIONS ON THE LICENSE SET FORTH IN AN END USER LICENSE AGREEMENT AND A SUPPLEMENTAL LICENSE AGREEMENT ACCOMPANYING THE PRODUCT OR AVAILABLE AT THE TIME OF YOUR ORDER.

TO THE EXTENT OF ANY CONFLICT BETWEEN THE TERMS OF THIS EVALUATION LICENSE AGREEMENT AND END USER LICENSE AGREEMENT OR ANY SUPPLEMENTAL LICENSE AGREEMENT, THE EVALUATION LICENSE AGREEMENT SHALL APPLY. BY DOWNLOADING, INSTALLING, OR USING THE SOFTWARE, YOU ARE REPRESENTING THAT YOU RECEIVED THE SOFTWARE FROM AN APPROVED SOURCE AND YOU ARE BINDING YOURSELF TO THE TERMS OF THE EVALUATION LICENSE AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THE EVALUATION LICENSE AGREEMENT, THEN CISCO IS UNWILLING TO LICENSE THE SOFTWARE TO YOU AND (A) YOU MAY NOT DOWNLOAD, INSTALL, OR USE THE SOFTWARE, AND (B) YOU SHALL DELETE OR DESTROY THE SOFTWARE (INCLUDING ANY UNOPENED CD PACKAGE AND ANY WRITTEN MATERIALS) AND ALL CONFIDENTIAL INFORMATION, OR, IF THE SOFTWARE AND WRITTEN MATERIALS ARE SUPPLIED AS PART OF ANOTHER PRODUCT, YOU SHALL DESTROY THE ENTIRE PRODUCT.

CAPITALIZED TERMS USED IN THIS EVALUATION LICENSE AGREEMENT BUT NOT DEFINED WILL HAVE THE MEANINGS ASSIGNED TO THEM IN THE END USER LICENSE AGREEMENT.

- 1. LICENSED TECHNOLOGY; EVALUATION.** Cisco shall supply to Customer the Licensed Technology described and listed on **Schedule A** attached hereto ("Licensed Technology") to enable Customer to evaluate the Licensed Technology solely in connection with Customer's internal business purposes and to determine whether to purchase the non-evaluation version of the Licensed Technology from Cisco ("Evaluation"); Customer shall access and evaluate the Licensed Technology for purposes of the Evaluation only.
- 2. LIMITED LICENSE GRANT; RESTRICTIONS.** For the Evaluation Period listed below, Cisco grants to Customer a limited, non-exclusive, royalty-free, non-assignable, non-transferable, non-sublicensable license to use the Licensed Technology solely for the purpose of Evaluation. Customer may not distribute, make commercial use of, publicly perform, or publicly display the Licensed Technology without separate written permission from Cisco. The Licensed Technology must be used and reviewed in a secure evaluation environment and properly managed at all times so as to prohibit and prevent access to the Licensed Technology in violation of this Evaluation License Agreement.

Customer shall not perform, nor allow, authorize, or assist others to perform copying, reverse engineering, decompilation, disassembly, modifying, or the like upon any portion of the Licensed Technology to attempt to learn information about its internal architecture, design, operation, manufacture, features, or functionality.

3. **TERM; TERMINATION.** Customer may evaluate the Licensed Technology for a nonrenewable, non-extendable period of 90 days (“Evaluation Period”), beginning with the installation date of the Licensed Technology by Customer. Customer’s rights under the Evaluation License Agreement will terminate immediately without notice from Cisco if Customer fails to comply with any provision of the Evaluation License Agreement. Upon the expiration of the Evaluation Period or upon termination of this Evaluation License Agreement, Customer shall delete or destroy all copies of the Licensed Technology and any related confidential information.
4. **OWNERSHIP.** The Licensed Technology and any confidential information provided by Cisco, and all involved or related intellectual property rights therein or thereto, are and shall remain the property of Cisco or its licensors. Customer is not obligated to provide Cisco with comments or suggestions regarding Licensed Technology or any related confidential information provided by Cisco. Should Customer, however, provide Cisco with comments or suggestions for the modification, correction, improvement, or enhancement of (a) the Licensed Technology or any related confidential information or (b) Cisco products which may embody the Licensed Technology or any related confidential information, then Customer grants to Cisco a non-exclusive, irrevocable, worldwide, royalty-free license, including the right to sublicense Cisco licensees and customers, under Customer’s intellectual property rights, the rights to use and disclose such comments and suggestions in any manner Cisco chooses and to display, perform, copy, have copied, make, have made, use, sell, offer to sell, and otherwise dispose of Cisco’s and its sublicensees’ products embodying such comments or suggestions in any manner and via any media Cisco chooses, but without reference to the source of such comments and/or suggestions.
5. **DISCLAIMER.** The Licensed Technology and other Confidential Information is provided and licensed “**AS IS**” and without warranty. CISCO DISCLAIMS ANY AND ALL WARRANTIES AND GUARANTEES, EXPRESS, IMPLIED, OR OTHERWISE, ARISING WITH RESPECT TO THE LICENSED TECHNOLOGY OR ANY CONFIDENTIAL INFORMATION, INCLUDING BUT NOT LIMITED TO THE WARRANTY OF MERCHANTABILITY, THE WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE, AND ANY WARRANTY OF NON-INFRINGEMENT OF THE INTELLECTUAL PROPERTY RIGHTS OF ANY THIRD PARTY. CISCO NEITHER ASSUMES NOR AUTHORIZES ANY PERSON TO ASSUME FOR CISCO ANY OTHER LIABILITY. CISCO WILL NOT BE LIABLE TO LICENSEE FOR ANY DIRECT OR INDIRECT DAMAGES INCURRED IN USING ANY OF THE LICENSED TECHNOLOGY OR OTHER CONFIDENTIAL INFORMATION AND IN NO EVENT WILL CISCO BE LIABLE FOR LOSS OF PROFITS, LOSS OF USE, OR LOSS OF DATA OR BUSINESS INTERRUPTION, NOR FOR PUNITIVE, INCIDENTAL, CONSEQUENTIAL, OR SPECIAL DAMAGES OF ANY KIND, EVEN IF ADVISED IN ADVANCE OF THE POSSIBILITY OF SUCH DAMAGES.
6. **CONTROLLING LAW; JURISDICTION NO IMPLIED LICENSE.** Cisco and Customer agree to be bound by the section “Controlling Law, Jurisdiction” of the End User License Agreement.

- 7. WAIVER AND SEVERABILITY.** All waivers must be in writing. Any waiver of either party to enforce a provision of this Evaluation License Agreement on one occasion will not be deemed a waiver of any other provision or such provision on any other occasion. This Evaluation License Agreement may only be amended by a written document signed by both parties. In the event that any of the provisions of this Evaluation License Agreement shall be held by a court or other tribunal of competent jurisdiction to be unenforceable, such provisions shall be limited or eliminated to the minimum extent necessary so that this Evaluation License Agreement shall otherwise remain in full force and effect and enforceable.
- 8. NOTICE.** All notices, requests, and other communications under this Evaluation License Agreement must be in writing and must be mailed by registered or certified mail, postage prepaid and return receipt requested, or delivered by hand to the party to whom such notice is required or permitted to be given. If mailed, any such notice will be considered to have been given five (5) business days after it was mailed, as evidenced by the postmark. If delivered by hand, any such notice will be considered to have been given when received by the party to whom notice is given, as evidenced by written and dated receipt of the receiving party. The mailing address for notice to Cisco is 170 West Tasman Drive, San Jose, California, Attention: Vice President and General Counsel. Either party may change its mailing address by notice as provided by this section.
- 9. CISCO'S OBLIGATIONS.** Cisco assumes no obligation to provide products or information to Customer for evaluation. Cisco shall have no obligation to provide support for the Licensed Technology, or to develop a final version thereof or license any version thereof. Under no circumstances does this Evaluation License Agreement obligate Cisco in any way to sell, lease, or otherwise provide any ownership interest in, or offer a license to use, the Licensed Technology during or after the Evaluation Period.
