



## Offer Description - Product Cisco Secure Workload

This Offer Description is part of the [General Terms](#) or similar terms existing between You and Cisco (.g., the End User License Agreement) (the “Agreement”). Capitalized terms, unless defined in this document, have the meaning in the Agreement. Any references to the Software End User License Agreement or SEULA mean Offer Description.

### 1. Summary

This Offer Description applies to Cisco Secure Workload products identified below (collectively, the “**Product**”). Cisco Secure Workload on-premises software provides workload protection and endpoint visibility across any workload, environment, or location from a single console, enabling customers to manage workloads securely and consistently.

- 2.1 Support.** Your purchase of the Product includes [Cisco Software Support Services](#). You will be required to select either Basic or Enhanced at the time of purchase.
- 2.2 Cisco SecureX.** Your Product subscription includes access to Cisco SecureX, Cisco’s integrated security platform that unifies visibility across various Cisco and third-party security products, enables automated workflows, and more. ### 3. Data Protection

**Personal Data.** The Cisco SecureX Privacy Data Sheets (available at [Cisco’s Trust Portal](#)) describe the Personal Data that Cisco collects and processes as part of the delivery of Cisco SecureX.

### 4. Special Terms

- 4.1 Product APIs and Apps.** Product APIs and Apps are licensed to you to use and make calls to the Product APIs and Apps for the sole purpose of developing and implementing software applications that work, communicate, or interact with Your licensed Products. You agree not to assert any of Your intellectual property developed with use of and/or used with the Product APIs or Apps against Cisco or any of its affiliates, customers, resellers, distributors, or other licensees of the Product APIs and Apps for making, having made, using, selling, offering for sale, or importing: (i) any products or services implementing, interfacing with or operating in combination with the Product APIs or Apps; or

(ii) any applications developed using the Product APIs or Apps. If You do not agree with the foregoing terms for Product APIs and Apps, do not use such functionality.

- 4.2 **Cisco Secure Workload Policy Enforcement.** If You ordered the Secure Workload Policy Enforcement feature as an add-on, Your license to the Secure Workload Policy Enforcement feature covers up to the number of Workloads you have licensed for that feature. If You had previously held a Product license and have not licensed the Secure Workload Policy Enforcement feature, or if no Workload quantity is specified for a Secure Workload Policy Enforcement feature license, Your license does not extend to that feature.
- 4.3 **Cisco Secure Workload Endpoint Visibility.** The Secure Workload Endpoint Visibility capability is licensed (on a per Endpoint basis) separately from the Secure Workload protection capability. Your license to the Secure Workload Endpoint Visibility feature provides an integration of telemetry from Endpoints running the Cisco Secure Client Network Visibility Module or managed through an Identity Services Engine (“ISE”) integration. Secure Workload Endpoint Visibility feature requires that you separately subscribe for the Cisco Secure Client Network Visibility Module and/or Cisco ISE for each Endpoint providing telemetry to the Product in both cases with the appropriate license and software version running. - 4.4 **Cisco Secure Workload Multi-Tenant Support.** The Product provides support for multiple subgroups on a single platform. Unless your PID description provides otherwise, your Product is licensed for use with only a single customer.
- 4.5 **Smart Licensing.** Cisco Smart Licensing will become mandatory for use of the Product in a future release. Once enabled, each Product license will be subject to and conditioned upon You enabling and maintaining Smart Licensing for the Product. - 4.6 **Definitions**

“**Endpoint**” means a device that leverages the network for communication or data processing and is using, monitored, or managed by the Software or Cloud Service.

“**Workload**” means an application, service, virtual machine, or other virtualized instance that communicates with and/or is managed by the Software or Cloud Service.
