Cisco announces the end-of-sale and end-of-life dates for the Cisco ACI Software Releases 5.3 and 15.3. The last day to order the affected product(s) is November 22, 2024.

Last Ship Date: OS SW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	November 22, 2024
End of SW Maintenance Releases Date: OS SW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	April 30, 2025
