

# Cisco HX Data Platform Software Versions 1.8, 2.0 and 2.1

Cisco announces the end-of-life dates for the Cisco HX Data Platform Software Versions 1.8, 2.0 and 2.1.

Software maintenance support for 1.8, 2.0 and 2.1 software releases end on December 1, 2018. No bug fixes, patches or maintenance releases will be provided for these Cisco HyperFlex Data Platform releases after that date. The last date of support for Cisco HX Data Platform Software Versions 1.8, 2.0 and 2.1 is March 1, 2019.

Starting from September 1, 2018, only sev1 and security vulnerability issues will be addressed with HX Data Platform releases 1.8.x, 2.0.x and 2.1.x. It may be necessary to upgrade to later software release to correct a reported problem.

Software maintenance requires an active service contract.

# Product migration options

Customers currently running HyperFlex Data Platform 1.8.x, 2.0.x and 2.1.x should upgrade by December 1, 2018 to the latest Suggested Release. Cisco HyperFlex Data Platform's Software Download page to get the latest Suggested Release can be found here:
