Cisco announces the end-of-sale and end-of-life dates for the Cisco ISR Serial Cables. The last day to order the affected product(s) is May 8, 2020 . Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
