Cisco announces the end-of-sale and end-of-life dates for the Cisco Select 4300ISR. The last day to order the affected product(s) is May 10, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. End-of-Life Announcement Date	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	November 9, 2020
End-of-Sale Date: HW,License	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	May 10, 2021
Last Ship Date: HW,License	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	August 8, 2021
End of SW Maintenance Releases Date: HW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	May 10, 2022

Last Date of Support: HW	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	May 31, 2026
