#### EOL12789 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Cisco End-of-Sale and End-of-Life Announcement of 896 and 897 VDSL2/ADSL2+ Routers. The last day to order the affected product(s) is July 29, 2019. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

| End of Service Contract<br>Renewal Date:<br>HW     | The last date to extend or renew a service contract for the product.  | October 24, 2023 |
