Cisco announces the end-of-sale and end-of-life dates for the Cisco ASR1000 release PIDs, SIP40 special bundle PIDs and modular ASR1000 Cisco One PIDs and other miscellaneous PIDs. The last day to order the affected product(s) is October 22, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
