

## End-of-Sale and End-of-Life Announcement for the Cisco CRS-1 Series 4-Port 10GE Interface Module

Cisco announces the end-of-sale and end-of-life dates for the Cisco CRS-1 Series 4-Port 10GE Interface Module. The last day to order the affected product(s) is March 31, 2015.
