

## End-of-Sale and End-of-Life Announcement for the Cisco vEdge 100wm Series Router

Cisco announces the end-of-sale and end-of-life dates for the Cisco vEdge 100wm Series Router. The last day to order the affected product(s) is November 15, 2019.
