Cisco announces the end-of-sale and end-of-life dates for the Cisco Unified Computing System C480 ML M5. The last day to order the affected product(s) is December 16, 2021. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. <b>End of SW Maintenance Releases Date: HW</b>	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software.	December 16, 2022

<b>End of Service Contract Renewal Date: HW</b>	The last date to extend or renew a service contract for the product.	March 13, 2026
<b>Last Date of Support: HW</b>	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	December 31, 2026
