Cisco announces the end-of-sale and end-of-life dates for the Cisco C1-AIR-K9-T and C1-AIR-K9-T-1Y. The last day to order the affected product(s) is January 18, 2020. Last Ship Date License	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	April 17, 2020
