Cisco announces the end-of-sale and end-of-life dates for the Cisco IOS XE Software Release 3.2.0SG and Cisco IOS Software Release 15.0(2)SG for Cisco Catalyst 4500 Series and Cisco Catalyst 4900 Series Fixed-Configuration Switches. The last day to order the affected product(s) is October 29, 2014. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

<b>End-of-Life Announcement Date</b>	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	April 30, 2014
<b>End-of-Sale Date</b>	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	October 29, 2014
<b>Last Ship Date: OS SW</b>	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	October 29, 2014
<b>End of SW Maintenance Releases Date: OS SW</b>	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes for IOS XE 3.2.0SG and IOS 15.0(2)SG. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software. The only exception is Vulnerability/Security issues that will be addressed as shown in the End of Vulnerability/Security Support milestone below.	October 29, 2015
<b>End of Vulnerability/Security Support: OS SW</b>	The last date that Cisco Engineering may release bug fixes for Vulnerability or Security issues for IOS XE 3.2.0SG and IOS 15.0(2)SG. After this date, bug fixes for Vulnerability or Security issues identified in IOS XE 3.2.0SG and IOS 15.0(2)SG may be provided through later supported software releases. Note that there will be no rebuild releases of IOS XE 3.2.0SG and IOS 15.0(2)SG provided after this End of Vulnerability/Security Support milestone date.	October 28, 2016
<b>Last Date of Support</b>	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	October 31, 2019
