Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

End-of-Life Announcement Date	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	August 31, 2017
End-of-Sale Date: OS SW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	November 30, 2017
Last Ship Date: OS SW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	November 30, 2017
End of SW Maintenance Releases Date and Vulnerability/Security Support: OS SW	The last date that Cisco Engineering may release any final software maintenance releases or bug fixes or Vulnerability and Security issues for IOSXE 16.5.1. After this date, Cisco Engineering will no longer develop, repair, maintain, or test the product software. Bug fixes for Vulnerability or Security issues identified in IOSXE 16.5.1 may be provided through later supported software releases.	May 31, 2018
Last Date of Support: OS SW	The last date to receive applicable service and support for the product as entitled by active service contracts or by warranty terms and conditions. After this date, all support services for the product are unavailable, and the product becomes obsolete.	November 30, 2022
