

# End-of-Sale and End-of-Life Announcement for the Cisco Nexus 9300 Series 93128TX Switch

#### EOL11766 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Cisco Nexus 9300 Series 93128TX Switch. The last day to order the affected product(s) is October 30, 2017.
