Cisco announces the end-of-sale and end-of-life dates for the Cisco N9K-X9564TX Linecard On Cisco Nexus 9500. The last day to order the affected product(s) is May 12, 2018. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	August 10, 2018
