Cisco announces the end-of-sale and end-of-life dates for the Cisco Smart PHY 300 & 600 Shelves. The last day to order the affected product(s) is April 30, 2025. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin.
