Cisco announces the end-of-sale and end-of life dates for the Cisco GainMaker High Output Amplifiers. The last day to order the affected product(s) is December 12, 2017. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active service contracts or active product warranties, support will be available for the shown dates as stated in the applicable service contracts or product warranty terms and conditions.

Specific Cisco 1 GHz GainMaker High Output Amplifiers with very low or no sales for the past three years are being discontinued.
