Overview

Cisco announces the end-of-sale and end-of-life dates for the Cisco Aironet 1552H, 1552S, and 1552WU Outdoor Access Points. The last day to order the affected product(s) is December 19, 2019. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

End-of-Life Announcement Date	The date the document that announces the end-of-sale and end-of-life of a product is distributed to the general public.	June 20, 2019
End-of-Sale Date: HW	The last date to order the product through Cisco point-of-sale mechanisms. The product is no longer for sale after this date.	December 19, 2019
Last Ship Date: HW	The last-possible ship date that can be requested of Cisco and/or its contract manufacturers. Actual ship date is dependent on lead time.	March 18, 2020

There is no replacement available for the Cisco Aironet 1552H, 1552S, and 1552WU Outdoor Access Points at this time.

On June 10th, 2019, Cisco announced the Cisco Catalyst IW6300 Heavy Duty Access Point. The IW6300 is the successor to the 1552H, 1552S, and 1552WU access points. Information on orderability of the IW6300 will be made public as it becomes available.

Customers may be able to use the Cisco Technology Migration Program (TMP) where applicable to trade-in eligible products and receive credit toward the purchase of new Cisco equipment. For more information about
