Overview

EOL12793 - Amended

Cisco announces the end-of-sale and end-of-life dates for the Cisco Euro-DOCSIS and Japan-DOCSIS versions of Cisco Aironet 1570 Series Access Points. The last day to order the affected product(s) is April 30, 2019. Customers with active service contracts will continue to receive support from the Cisco Technical Assistance Center (TAC) as shown in Table 1 of the EoL bulletin. Table 1 describes the end-of-life milestones, definitions, and dates for the affected product(s). Table 2 lists the product part numbers affected by this announcement. For customers with active and paid service and support contracts, support will be available under the terms and conditions of customers' service contract.

The other versions of the AP1570 Series are not affected by this announcement. Specifically, the AP1572EAC and AP1572IC1, 1572IC2, 1572EC1 and 1572EC2 (standard DOCSIS 3.0 cable modem versions) will remain orderable.
